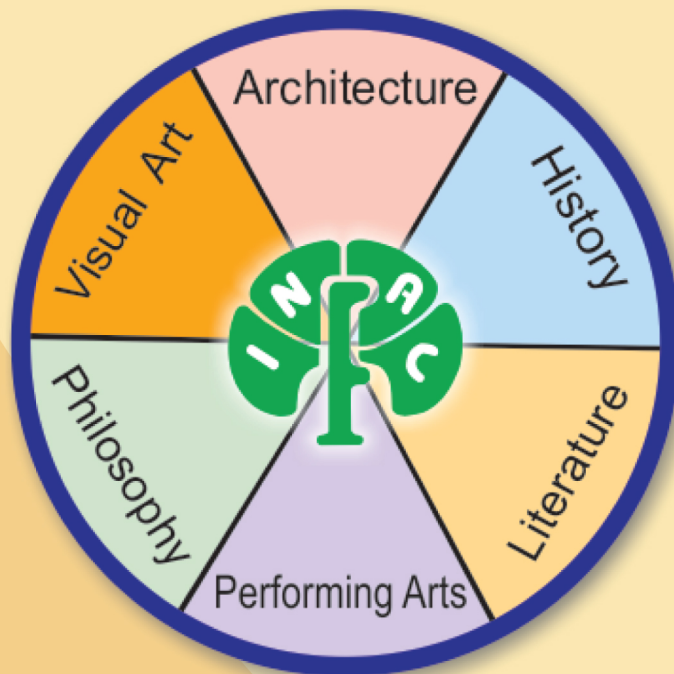

## INSTRUCTIONS TO CONTRIBUTORS

1. Originality in writing is the *sine qua non* of any article intended to be published.
2. The article must be an unpublished one.
3. Essential requisites of an article: There must be (a) an Abstract in the beginning restricted preferably to 100 words indicating only of the scope and major findings of the article/paper; (b) sub-heading, where necessary; (c) citations within text should be enclosed in parentheses following the author-date system, for example, (Ganguly 2001) and the full bibliographic information given in the list of references; (d) full form of abbreviations, when used; and (e) a short introduction of the author within 50 words.
4. Article submission formalities: (a) The article must be submitted with a (i) hard copy duly signed by the author together with a soft copy thereof; (ii) coloured passport size photograph of the author with full name in block letters at the back of the photograph; (iii) certificate in case of a research scholar from the research guide to the effect that the article is fit for publication. (b) The article must be restricted at the maximum length of 10 pages and composed: (i) when in English: on A4 size paper using *Times New Roman* font set in one-and-a-half line spacing; (ii) when in Bengali: on A4 size paper using *Shonar Bangla* font set in one-and-a-half line spacing; (iii) when in Hindi: on A4 size paper using *Kokila* font set in one-and-a-half line spacing..
5. Copyright: Copyright of each published article shall belong to Indian National Forum of Art and Culture.
6. Complimentary copy: The author will get a complimentary copy of the journal containing his/her article on publication thereof.
7. Return of Manuscript: No manuscript whether accepted for publication or not shall be returned to the author.
8. Caution: Submission of any article does not mean its automatic acceptance by the management for publication thereof in the journal. The publication of any article is subject to clearance of the Editorial Board and Peer Body.

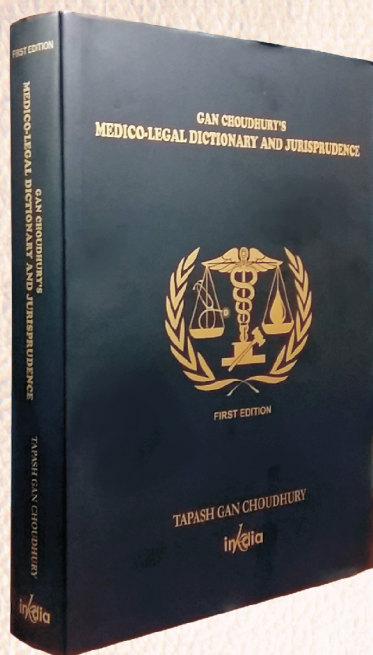
